### **BUSINESS ARISING FROM MINUTES**

## Lumberjacks

Met with Lumberjacks regarding South Shore Ice Sharks changing to Lumberjacks. Hurricanes will be merging next season.

Lumberjacks want to achieve:

- All teams change over to the Lumberjack branding. Keep our current colors and look at placing a
  twill logo over the Ice Shark logo on jerseys that are still usable. Looking at \$7 per logo plus cost of
  sewing them on. Exception will be the IP program, Novice Timbits, and McAtom jerseys.
- Second, the Timberland is looking for someone to run on-site merchandise. With that, could sell SSMHA merchandise as well.

## Lumberjacks offer to:

#### Year 1

- Run our Conditioning Camp in partnership with their daytime camp. The daytime camp would be for the more skilled kids and the night-time camp would be for anyone.
- Run all on-ice sessions during tryouts no evaluation just running the sessions.
- Completely run our conditioning camp and would love keeping FinnGoalie involved.
- Once we get our schedules for each team we give them the schedule and they would make sure that every team gets at least 1-2 players from the Jacks there to help. Obviously, this wouldn't be the case if they were on the road.

Year 2 - same offers as year 1, plus:

 They would look after taking over all aspects of the technical part of our program. Coaching coaches, running development sessions, etc. Plus, they would be there for all our teams for help and guidance.

The SSMHA doesn't have the money to support a paid technical Director, but SSMHA has access to grant applications..

Moved and seconded that the SSMHA Ice Sharks change to the SSMHA Lumberjacks starting in the 2018-2019 season. Motion carried.
